## Seal of Approval



Why does everything interesting happen when we are gone? We were in the below sea level area of Death Valley and when I got to civilization my phone blew up with messages. "There's a baby seal on the beach!"

What a wonderful and concerning thing to happen. I received many comments

about how to close down the beach to dogs so the baby elephant seal was not in any danger. Since the office was closed, please remember you can always call and leave a message or call the Marine Mammal Center at 415-289–7350.

Luckily, we have a volunteer from the Marine Mammal Rescue living here in the park. I did an article a couple of months ago on Winnie Mule', who has been a volunteer for many years. She was contacted and Hopper was safely removed!

Hopper is a Northern Elephant Seal, the second most commonly rescued species. The Marine Mammal Center typically sees orphaned pups that have been stranded during mid-February to late June. Strong storms often wash these young seals off beaches before they have weaned from their mothers or learned how to survive on their own. This results in many malnourished and underweight pups needing rehabilitative care. Northern

Elephant Seals suffer from disease as well, such as skin disease, pneumonia and

parasites like lungworm.

#### RECYCLING DUMPSTER

There is a new recycling dumpster located by the Clubhouse. You can now use it for your recycled items and/or large cardboard items THAT HAVE BEEN BROKEN DOWN PROPERLY.

Don't forget about the **Spring Cleaning** event on Saturday, May 14, 9AM to 12PM, Enrique will be driving around in a rental pick-up truck to assist in larger, approved, items that need to be dumped. Management will host salad and sandwiches from Togo's 12pm-1pm. Check the email blast from management for what items are allowed and not allowed, or call the office.

#### **RODENT INFORMATION**

It was brought to my attention that some residents are using poisoned baits to get if it is unacceptable.

"Rats and mice that feed on these baits can take several days to die. The poisoned rodents become increasingly weak, making them easy prey for predators. Hungry raptors or other wildlife can receive a lethal dose when they feed on the poisoned rats and mice. This is tragic not merely because hawks, owls, foxes and other animals are dying, but because wildlife predators provide us with valuable rodent control services – unless of course we kill them first." http://saferodentcontrol.org/site/wildlife/




#### Tick Season is Here!

## HOA Meeting Minutes

# DEANZA MOBILE HOME PARK HOMEOWNERS ASSOCIATION (HOA) General Membership Meeting Minutes Saturday, March 19, 2022 11a.m.

#### **Call to Order**

Eugene Markowitz called the meeting to order at 11:00 a.m. The members recited the Pledge of Allegiance.

#### **Roll Call**

The Secretary took roll call of the Board Members.

Board members present were: Don Payne, Lorraine Smith, Sandi Dutra, Eugene Markowitz, Dave Allenbaugh

Not present: Jerry Zanzinger, Gary Whitten, and Tom Louden

There is one vacancy on the Board.

There were 25 members of the HOA present at the meeting.

#### **President's Report**

Jennifer told Eugene that management was trained to turn off the gas in the event of an emergency. What happens if management cannot be contacted? Eugene will discuss with Jennifer. ELS is replacing gas meters per Weights and Measures Dept. If a members gas meter looks like it needs replacing, they should contact management.

A resident was concerned that sometimes the outgoing gate does not open. We have three residents that can open the gate if necessary. They are Jim Carraher, Jim Cannon and Dave Allenbaugh.

It was initially thought that emergency planning was an ELS responsibility. Upon further discussion with management it was determined the community can have their own emergency plan. Management must provide an evacuation plan. However, there should be some contact with ELS regarding emergencies and that is why we have a board member who has the designation of Emergency Procedures. The website Ready.gov is a good source for information regarding emergencies.

Eugene discussed his conversations with a city employee who informed him that we can have a unit that accepts carboard as well as other recycled trash. We might use those containers on a trial basis to see if they work. They will look in to replacing the heavy lids with lighter ones.

The garbage committee was concerned about the lids, food waste, signage and pet waste. There should be pet waste locations. You can fill out a form to take food waste to two locations. They are Trescony Park and a location near City Hall. They will send you an email with the lock combination. At the end of the year, the city may pick it up. The April Bulletin has a list of what items you can put in the food waste. You might want to cut it out and put it on your refrigerator.

There will be general cleanup Friday to Monday starting May14. ELS will provide a dumpster for unwanted items. Jennifer will let us know what can go in the dumpsters.

Jennifer said there was a report to the Coastal Commission and Fish & Wildlife. (Report was provided, see page 11). We need to get a copy of the report. We have a right to get a copy. If ELS does not give it to us, we should go directly to the Coastal Commission. Jennifer stated they are working on getting native fish. We should inform the Coastal Commission that we don't have them yet.

A new resident was acknowledged

#### **Vice Presidents Report**

There was no report from the Vice President.

#### **Secretary's Report**

Eugene asked if there were any changes or additions to the prior meetings minutes. Since there were no changes or additions, the prior minutes were approved.

#### **Elections**

Eugene stated the qualifications to vote. The nominating committee chaired by Candi Walker gave the following report for the new officers and directors.:

Those nominated:

Eugene Markowitz, incumbent running for President.

Karen Scott, Vice President

Jerry Zanzinger, incumbent running for Secretary

Heidi Armstrong, Treasurer (It was subsequently learned that she will not be running for office, so the spot is still open.)

Gary Whitten, incumbent running for Emergency Procedures.

Margaret Gannon, Park Concerns

Lorraine Smith, incumbent running for Communications.

Candi Walker, GSMOL

Don Payne, incumbent running for Policies and Procedures

All of the above will also be a Director of the HOA.

#### **Treasurer's Report**

Sandi gave a report on the current condition of the HOA's funds. We have about \$1,600 in the general account and 18,000 in the JAMs account. 40 units have paid the HOA dues. There has been a Bylaw change to change our fiscal year to the calendar year.

Sandi distributed handouts to the residents informing them of the procedures used by ELS to determine rent increases. It is anticipated that next year's increase will be substantial since the February CPI is 5.2%. Our leases use the Bay Area CPI and not the National one that takes into consideration Social Security.

#### **Policies and Procedures**

Don asked how many people use the Spa. About half of the membership raised their hands. The hot tub had a pump leak. The hot tub has an auto measuring system that is usually pretty good but there were some problems. PH was low in the hot tub. The pool is always fine. Don said he would send a stern letter to Jennifer copying upper management regarding the problem. If there is a health and safety issue, they have to fix it immediately. Management has to meet with you within 30 days of filing a complaint.

#### **Emergency Procedures**

Gary was out ill therefor there was no report. Karen Blagmon and Shannon Gannon volunteered to be on the committee.

#### **GSMOL**

Assembly Bill 869, which has not passed yet, would require 18 hours of management training. AB 2031, not passed yet, would require management to meet with you within 30 days after filling a complaint and the new provision is, they have to respond within ten days after meeting with you, written or otherwise.

#### **Communications**

Lorraine said there were only two people over the last two years who unsubscribed to our website. Traffic is very good. Contact Lorraine to put in articles for the bulletin. For the April Bulletin, she has to receive articles by March 15. She continues to update the resident list. A resident can opt out if they like.

#### **Adjournment**

The meeting was adjourned by Eugene Markowitz at 12:40 p.m.

# This report is intended to keep residents updated on a regular basis of HOA and Management accomplishments in our community.

HOA Board President Eugene Markowitz met with Park Manager Jennifer McClellan to discuss issues from our bi-monthly Homeowners Meeting.

- 1) A discussion was held regarding a major disaster in our area that would require the gas and water mains being turned off and management not in the park. Jennifer was open to a few residents being trained to turn off those mains. She also expressed an interest in working with the HOA on Disaster planning.
- 2) A copy of ELS yearly report to the California Coastal Commission was requested and received. Copies of the report were distributed to Jean Marie Mott, who is on the landscaping committee and the HOA Board.
- 3) In response to Residents' concerns that there is only one cardboard dumpster. A walk through the park with a City utilities supervisor and Jennifer was arranged, resulting in DeAnza experimenting with a new combination recycle/cardboard 2 yard dumpster located at the dumpster near the clubhouse. It is currently in place in that area. The supervisor is also looking into replacing the thicker heavier garbage dumpster lids with lighter ones.

In addition, Jennifer has placed laminated signs at the dumpsters reminding residents that there is a cardboard dumpster behind space 8.

4) Jennifer confirmed that ELS will be having a large dumpster available for residents on the weekend of May 14
