### WHO ARE THOSE PEEPERS?

What are those women on the bridge with binoculars looking at? What birds are they seeing?

In February, we might be looking for the Anna's Hummingbirds that start to nest in the park. They use lichen and spider webs to build their nest, generally close to the tip of a branch. The nest starts out small (mom doesn't even fit inside), but the spider webs allow it to stretch as the babies grow. (Note, the female lacks the bright red forehead & throat.)









In March, we want to see who is checking out our nest boxes. Last year by the middle of the month a Chestnut-backed Chickadee pair had completed its nest in box #10, ready to raise a family of 5.



In April, we will be watching for the migratory birds to come in to start nesting. The Tree Swallows used box #6 near the pond. This was an expansion of its breeding range in the county.

In the fall our migratory breeding birds will be leaving and the migratory birds that spend the winter here will return. If you saw us out there December 18, we were looking for these wintering birds – as well as our year-round residents – for the annual Audubon Christmas Bird Count. We found 36 species in the park in just 4 hours that morning. A couple of the highlights from this year's count were 3 birds which will leave us in the spring, to breed elsewhere:

Townsend's Warbler

Ruby-crowned Kinglet – though you'd be very lucky to see the ruby crown!





White Crowned Sparrow (and it's cousin - Golden Crowned





The quality and variety of the habitat here at De Anza attracts many different species of birds. They really enjoy the new native plants around the ponds -- lots of good bugs and seeds. The *Ceanothus* with its purple flowers, provides both food and hiding places from predators.

The Green Heron needs the tules as camouflage when it is hunting for fish. And, of course, the trees are important for many birds, for food, nest sites, and perches.



We are not just interested in how many different species are here, but also in what the birds are doing. Do they have a nest? Is there a pair? Are they just stopping by for lunch or dinner? Have they ever been here before? Do they live here year-round, or just visit? Sometimes you will see us standing in a place for a long time looking and looking. We may be trying to figure out a puzzle. For instance, we know that there are Common Yellowthroat breeding here in the park, but we have never found their nest. So, we try to watch where the adults go, but they are very secretive.

Keeping track of which birds nest in the park is an important part of a county record. 24 different species of birds have been confirmed to nest here over the past three years! Our observations will be included in the upcoming Breeding Bird Atlas of Santa Cruz County.

If you see us out walking around or standing still please come up and ask us what we are seeing. And, we love the reports from you as well.





### DEANZA MOBILE HOME PARK HOMEOWNERS' ASSOCIATION (HOA) General Membership Meeting Minutes Saturday, January 15, 2022 11a.m.

**Call to Order:** Eugene Markowitz called the meeting to order at 11:00 a.m. The members recited the Pledge of Allegiance.

**Roll Call:** The Secretary took roll call of the Board Members. Those members present were: Eugene Markowitz, Tom Louden, Jerry Zanzinger, Sandi Dutra, Don Payne, Gary Whitten, Dave Allenbaugh, Lorraine Smith. There is one vacancy on the Board.

There were 25 members of the HOA and 8 Board members present at the meeting. Management was invited but did not attend due to Covid exposure.

### **President's Report**

Eugene said that he emailed Jennifer specific questions and she responded as follows: Emergency gas cutoff is handled by management. There are three people who can do it. It was recommended that a few residents be given the cutoff instructions in case management is absent. Eugene will follow-up with Jennifer. Eugene will ask Jennifer to provide us the names of native fish that can be purchased to restock the ponds. Once we have the names residents can look to see where we can buy them. Jennifer said that she sent in the annual report to the CCC as required. It was brought up that we are entitled to a copy and Eugene was asked to request it. About the new state law that requires composting, ELS is investigating for all their CA properties. The specifics have not been decided. Eugene read Article 8 of the Bylaws that relates to nomination and election procedures. Three residents volunteered to be on the nomination committee, Nancy Scheidt, Candi Walker, and Susan Campbell.

### Vice President's Report.

There was no report from the Vice President.

### Secretary's Report

The Secretary asked if there were any changes or additions to the prior meetings minutes. Since there were no changes or additions, the prior minutes were approved.

### **Treasurer's Report**

Sandi Dutra gave a report on the current condition of the HOA's funds. A copy of the report is attached hereto. We have \$1,361 in the general account and \$18,043 in the JAMs account. Only monies spent from the general account were for the Web and 50% (\$107) was reimbursed by the Arroyo since we share access. She investigated putting the JAMs money into a higher earning account, but the Board found it fiscally unwise because it only provides an additional 0.49% in interest. It is also time to pay \$10 per unit for HOA fees. You must pay the fee to be eligible to vote in the Officers and Directors election at the membership meeting in May. Dues for the Arroyo Association for the social functions are separate, and they are charged per person.

### **Policies and Procedures**

No new information on policies and procedures.

### **Emergency Procedures**

Gary Whitten provided emergency documents received from Santa Cruz Fire. It provides information on what to do in the case of an emergency. Lorraine stated that it is on our website. He is still in the process of assembling a team. He has five volunteers and is looking for more. The walkie talkies have new batteries that have a 20-year shelf life. He will have a class on the use of the walkie talkies. Gary reiterated that ELS has the responsibility for emergency procedures in the park. They have a statutory mandate to provide a plan for emergency events. We only provide some additional help that relates to emergency procedures. Regarding gas shutoff during an emergency, it is recommended that residents turn off their gas if they smell it. The problem is turning it back on. That should be done by authorized personnel. Jane Heyse and Correy Baker (volunteered by Candi Walker) will also join Gary's group. A resident suggested that we should get communications from management when there is an emergency, such as a robo call.

### **Park Concerns**

There is a vacancy for park concerns. Eugene is filling in until someone is voted in at the May meeting.

### GSMOL

There is not much going on that is relevant to us. Most of the legislation refers to rent control issues. There is a park that was successful in their three-year case that concerned rent control.

### Communications

Lorraine said that website activity has increased substantially. There were 96 opens after her last email blast. The new resident list is continuing. A resident's name and email must be on the list to get an email blast from Lorraine. If you accidently unsubscribe, let Lorraine know and she will take care of it.

Next Wednesday you can sign up for free covid test kits at <u>www.covidtests.gov</u>.

### **General Discussion**

A resident was concerned that there is no compliance with the recycling rules for the park. People do not follow proper disposal of recycled material. A resident discussed the Santa Cruz mandate regarding composting and the 6-gallon pilot project. A committee was formed to investigate our recycling problems and to report back to the Board. The residents on the committee are Karen Scott, Sandy Brunett and Winnie Mule'. A resident discussed the ongoing problems with the dumpsters. The lids are too heavy at some of the locations and they are hard to access, especially for seniors. This has been a chronic problem and management needs to do something about it. Eugene will discuss with Jennifer. Another resident cited the problems associated with green waste disposal. The hours are not consistent to get through the gates. Items are put in the green waste dumpster that do not belong. One of the problems leaving it open 24 hours a day is that outsiders can easily access it. It was mentioned that it may cost \$700 per month to empty this bin although this is not part of residents' garbage bill. One suggestion that had much support is to control the gates by a fob so that residents can dump green waste any time and it would also keep out outsiders.

### Adjournment

The meeting was adjourned by Eugene Markowitz at 12:00 p.m.

Membership dues are used to defray costs of events and allows us to present most community events at no charge. And, of course, our bar prices can't be beat!



### "Why do I have to 'sign up' for De Anza Arroyo events?"


